With new European grant rules you can apply for a 4 day workshop:

The ALIPPE workshop on the dyslexic way of learning for prison - educators and - professionals:

The participant will be introduced to the reasons behind the high prevalence of dyslexics in prison. They will discover the different learning style of dyslexics. They will experience all the ingredients necessary to raise awareness of literacy improvement possibilities for dyslexic detainees. The participant will get to know what the challenges and the possibilities of the their dyslexic pupils encounter.

Participants will be getting the touch and feel of a literacy improvement course for dyslexics. A course with Multiple Intelligence self-awareness, Ridings cognitive styles, Memory and mind mapping techniques, methods for more effective reading, writing and presentation. The participant will be part of the process and will be invited to bring in his own circumstances and experiences (peer learning).

Expected outputs:

The participant will get basic awareness of the strengths of dyslexics. They may get an insight how to make literacy courses more dyslexia friendly. They will learn the basic concepts of multi-learning styles, those styles that are more appropriate and useful in dyslexic learning. The learners will get means to set up a course for dyslexic adults in raising awareness for literacy improvement possibilities and various methods and approaches for dyslexic learning and stimulating personal multi-learning skills.

Erasmus+ grant rules KA1

The European Union has launched the new Erasmus+ program. There is a new formula for attending courses.



- Only organisations can apply for Erasmus+ Key Action 1 (KA1) staff development mobilities (you must be part of an organisation)
- The organisational impact of a KA1 mobility (e.g. The ALIPPE course) must be justified in a so-called European Development Plan of the organisation.
- Organisations can apply for multiple staff members in one application. There is no limit on the number of participants, but there is a maximum of the total grant requested.

What have to be done to apply for a European support?

First: Your organisation needs to register for an ECAS account: Go to the European Commission Authentication Service (ECAS):

With this ECAS account one can login to the Participant Portal. The organisation can be registered on the Unique Registration Facility (URF): This gives a Participant Identification Code (PIC)

This PIC is needed to apply for a project proposal and describe the wanted KA1 mobility (mobilities).

The new Erasmus+ rules means that the applicant has to organize his grants via his organisations

Project Proposal. You have to justify applying for this course in the Europe Development plan.

All mobilities for the next year should fit in one European Development Plan.
